Deputy District Attorney Stephen Taylor*

Stephen E. Taylor is a San Joaquin County Deputy District Attorney since 1981. He specializes in criminal cases involving White Collar Crime such as Embezzlements and Investment Frauds – and Sexually Violent Predators.



Mr. Taylor graduated from University of California Hastings College of the Law in 1980. He is a previous decade-long Rotary Member (Downtown Stockton Club).

He will be speaking on the Embezzlement problems he has seen in San Joaquin County and how businesses can reduce their exposure to crippling losses from employee thefts. The good news is that many embezzlers are being convicted, sent to prison or jail, and over a million dollars has been recovered so far, this year for local victim businesses. The bad news is that large (over \$100k each) embezzlement cases are still coming in despite years of prosecutions.
